

## **TERMS AND CONDITIONS FOR REECE NEW ZEALAND “GETAWAY GIVEAWAY” INSTAGRAM PROMOTION**

1. Information on how to enter and prizes forms part of these Terms and Conditions. Participation in this “Getaway Giveaway” Instagram Promotion ( “Promotion” ) is deemed acceptance of these Terms and Conditions.

### **WHO CAN ENTER?**

2. Subject to condition 3, this Promotion is only open to NEW ZEALAND residents aged 18 years or over.
3.
